



### Road Course Rental Terms & Conditions

**Fees:** Deposit is required at time of reservation. If event day is on: Mon-Fri \$1,000 due /Sat or Sun \$1,500 due. Remainder of rental fees and all additional service fees **must be paid in full 30 days prior to the event.** (EMT/Ambulance, Wrecker, Corner Workers, Security Workers and Catering; constitute additional service fees.) Gate fee of \$10 and liability waiver must be paid and signed by **all**: crew, drivers, and spectators. Gate fee is necessary for anyone entering the European Motorsport Park. Track rental fee guarantees only the track and associated areas for use.

You will be charged for any damage or loss to property. A 7% Florida sales tax will be added.  
You will be charged for any equipment or tires left behind. A 7% Florida sales tax will be added.  
Any/all charges or fees incurred or assessed during the event must be paid at the end of the event.

**Insurance:** Insurance is to be provided by the organization renting the track. Proof of coverage is required two weeks prior to event. \*See Insurance Requirements document.

#### **Cancellations:**

- **More than 60 days prior to event:** Deposit and fees are refundable; only when requested in writing and approved by EMPRS.
- **Between 60-30 days prior to event:** Deposit and fees are not refundable but will be credited in full toward another track rental or event at EMPRS; only when requested in writing and approved by EMPRS.
- **Less than 30 days prior to event:** Deposit and fees are not refundable. Deposit is forfeited. If another Renter is found to book this event date, 50% of remaining rental fees and additional service fees will be credited toward another track rental or event. If no replacement renter is found, no fees will be credited.

**\*\*We run "rain or shine"**. If extreme weather or safety issues exist: EMPRS pro-rates by the hour if time is interrupted before Noon. If time is interrupted after lunch no credits will be given. A postpone date will be given for full days lost, as schedule allows. Refunds are not given by EMPRS.

#### **Transfer of Date:**

- **More than 30 days prior to event:** Deposits and fees are transferable to another event date. A 10% administrative fee of the full amount will be charged to transfer the event date.
- **Within 30 days of the event:** Transfers are not allowed. At this point a transfer is considered a cancellation. See above Cancellation policies.

**Please inform EMPRS as early as possible if cancellations are necessary.**

**Vendors:** Photography/videography is permitted at EMPRS discretion. Please inform EMPRS at time of reservation if you will be providing this service for your event. Liability must be discussed. Outside vendors are not allowed without prior written permission by EMPRS. Catering is available upon request. Final Catering guarantee is required 30 days before the event.
